

Terms & Conditions

1. Information on how to enter and prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

8. Promotion commences 15 September 2011. Entries close on 31 October 2011 at 5:59pm AEDST (for coupon or mailed entries) and at 11:59pm AEDST (for online entries).

10. The winner will be notified by telephone and email and their name published on the Europcar Australia website (www.europcar.com.au)
11. Should the initial winner not claim their prize within three months from the draw date, a redraw will be held on February 7, 2012. The redrawn winner will be notified in writing and the results of the redraw will be published on the Europcar Australia website (www.europcar.com.au) on 7 February 2012.
